Minutes of the Parish Council meeting held on Monday 6th February 2023 at Tewin Memorial Hall at 7.45pm.

107. THE MINUTES OF THE PREVIOUS PARISH COUNCIL MEETINGS held 5th December 2022 and 27th January 2023, copies of which have been previously circulated to Councillors, were confirmed as a true record and signed by the Chairman.

108. PARISHIONERS COMMENTS

Representatives of the Tewin Cricket Club attended to outline their ideas for an electronic LED scoreboard on the Pavilion with a hard cover to match the exterior of the Pavilion. The Parish Council suggested that an indicator light be used to show whether the scoreboard was on or off when the cover was on. They also suggested that it not stick out too much over the path. Overall the Parish Council supported the idea.

Planning applications

3/22/2573/FUL – Seven Pines, Margery Lane, Tewin - Demolition of bungalow. Erection of two storey dwelling – *TPC No Comment*

3/23/0200/FUL- Shire Park Bowls Club School Lane Tewin- Extension to canopy on North elevation, in white aluminium framing, framing and gutter will be in white. *TPC agreed to advise the Bowls Club Management that it appears that the relevant works have already been carried out and it is normal practice to wait for planning permission to be granted, before carrying out the relevant works*

3/23/0149/HH - 1 Desborough Drive Tewin - Demolition of conservatory and erection of a single storey rear extension incorporating roof lantern and alterations to fenestration – *TPC No Comment*

Welwyn Hatfield Times Local Plan – This is at the final modification stage and DIG1 has been removed.

3/22/2149/CLXU - Land To The North Of The B1000, Hertford Road, Tewin - To regularise an existing agricultural access (The Access) from the highway B1000 Hertford Road onto land at Tewin Water. The Access consists of a dropped kerb and three metal field gates set back from the road allowing farm vehicles to access the field from the highway. The access has been in existence and constant use since 1958 – *TPC No Comment – EHC Granted*

111. FINANCE

Senior Citizens Lunch – TPC agreed a donation of $\pounds 100$ to Friends of Tewin towards the Senior Citizens lunch. Friends of Tewin Donation - A donation of $\pounds 900$ was received from Friends of Tewin towards the purchase of football posts.

Barclays Bank Know Your Customer – A request for Cllrs to complete personal details forms in order to update the mandate has been completed. A complaint will be raised once completed.

VAT Reclaim – A VAT reclaim of £1819.56 has been received.

112. HIGHWAY MATTERS

Pothole in Orchard Rd next to leaking gulley - Reported

Damaged Upper Green Verges – The damage, which arose during the Godfries Close resurfacing works, was reported to Herts Highways. Cllr K Crofton advised that he would look into.

Waterside/B1000 Signage – Following two recent accidents at this junction, Cllr Ken Crofton advised that he has passed the Parish Council's concerns about the confusing signage to the relevant Herts Highways team.

New "Tewin" Signs – The Parish Council agreed to support the proposed replacement "Tewin" signs at the entrance and exits of the village. Cllr K Crofton asked for pictures of the proposed signs with a view to requesting that Highways adopt them. Friends of Tewin will be funding the signs through the Parish Council in accordance with Herts Highways requirements.

113. LOWER GREEN

Tewin Cowper PTA Easter Trail – The Parish Council agreed that they could use Upper And Lower Green as start and finish points for their annual Easter trail fundraiser on Sat 25th March, starting at 3pm and finishing at approx 5pm. **Sewer Leak** – A sewer leak outside 7 Lower Green was reported to Thames Water. Flytipping on Hertford Rd - This was reported to both Herts Highways and East Herts Council.

HMWT Letter of Support – The Parish Council agreed to a letter of support for HMWT and their work on Archers Green Wildlife site. The Parish Council also agreed to pay for the room hire at the Tewin Memorial Hall and for their newsletter distribution in the Parish.

Lower Green Edging Erosion – A concern has been raised about parking on Lower Green which is eroding the grass. The Parish Council agreed that it has been a particularly wet year which has made grass areas vulnerable. When the grass has had a chance to try to re-grow, the Parish Council will consider if there is anything appropriate which can be done. The problems on the north side of the green were much more serious, which justified the high cost of putting the kerbing in. The Parish Council is unlikely to pay for putting in a similar kerb on the south side. The Parish Council agreed to write to the School to ask that their parents to be more considerate of the green and will also put a note in the Tewin Magazine.

114. PAVILION & UPPER GREEN

Weekly Playground Inspections - Nothing to report.

Tewin Pavilion CIC Licence to Occupy – This has been signed by both parties.

Fire Alarm Service – This will be done by T&J Fire on 13.2.2023.

Electronic Scoreboard – As per "Parishioners Comments" above representatives of the Tewin Cricket Club attended to outline their ideas for an electronic LED scoreboard on the Pavilion with a hard cover to match the exterior of the Pavilion. The Parish Council supported their idea.

Football Goalposts – Cllr J Sheridan and Cllr A Hill agreed to liaise about installation of the football goal posts. **Pavilion Patio Water Pooling** – This is happens after heavy rain and is being monitored but to date flows away over night. **Pavilion External Light On** – Cllr K St Pier will reset it.
