Minutes of the Annual Parish Council meeting held on Monday 11th May 2015 in Tewin Memorial Hall at 7.45pm.

X/15/0117/CND - Sevenacres, Tewin - Hornbeam Hedge - A query has been raised that the hornbeam hedge on the northern boundary with the tennis courts has not been planted - Nothing to report.

Sevenacres - Remedial works on the new gulley installed by Taylor Wimpey which resulted in water flooding out onto the road have not been completed yet.

Riversmead Development Update - Remedial works on the corner of Grass Warren have been completed by Bugler. The repair works to the sunken manhole cover caused by a water leak require further works as the manhole cover is rocking, the tarmac surface is very undulating and the edges have not been finished off properly. Riversmead have agreed to do a site visit.

Rivergate Homes - The Parish Council are in the process of arranging a meeting with Rivergate Homes about co-ordinating with them over the works to reinstate the kerbing and the green.

7. FINANCE

Accounts for Payment - In accordance with the Council's Financial Regulations the schedule of payments amounting to £7,732.55 from the Current Account were approved by the Parish Council.

In accordance with the Council's Financial Regulations the schedule of payments amounting to £37.94 from the Tewin Pavilion account were approved by the Parish Council

Accounts for the Financial Year Ending 31.3.2015 – In accordance with the Council's Financial Regulations the Council RESOLVED unanimously to accept the accounts and they were signed by the Chairman and the Clerk as the Responsible Financial Officer.

Annual Return Section 1

The Parish Council RESOLVED unanimously to accept and approve Section 1 Statement of Accounts on the Annual Return for the financial year ending 31.3.2015. The Annual Return was signed by the Chairman and the Clerk as the Responsible Financial Officer.

Annual Return Section 2

The Parish Council RESOLVED unanimously to accept and approve Section 2 Annual Governance Statement on the Annual Return for the financial year ended 31.3.2015. The Parish Council confirmed that it:

- 1. Approved the accounting statements which have been prepared in accordance with the requirements of the Accounts and Audit regulations and proper practices.
- 2. Maintained an adequate system of internal control, including measures designed to prevent and detect fraud and corruption and reviewed it effectiveness.
- 3. Taken all reasonable steps to assure ourselves that there are no matters of actual or potential non compliance with laws, regulations and codes of practice which could have a significant financial effect on the ability of the council to conduct its business or its finances.
- 4. Provided proper opportunity during the year for the exercise of electors' rights in accordance with the requirements of the Accounts and Audit Regulations.
- 5. Carried out an assessment of the risks facing the Council and took appropriate steps to manage those risks including the introduction of internal controls and/or external insurance cover where required.
- 6. Maintained throughout the year an adequate and effective system of internal audit of the council accounting records and control systems.
- 7. Took appropriate action on all matters raised in reports from internal and external audit.
- 8. Considered whether any litigation, liabilities or commitments, events or transactions, occurring either during or after the year end, have a financial impact on the council and, where appropriate have included them in the accounting statements.

The Annual Return was signed by the Chairman and the Clerk as the Responsible Financial Officer.

BDO Audit Form – This was completed and signed by the Chairman and the Clerk.

Annual Internal Audit – This has been completed by McCash and Hay Accountants who confirmed that they found all the records to be in good order and have not had to qualify the report in any way. Section 4 of the BDO Audit Form was completed and signed by the auditor.

Newsletter and associated costs – The Parish Council agreed to send a newsletter to the parish comprising the Chairman's Annual report and informing parishioners about the proposed new tennis court fencing and screening. They also agreed to the associated photocopying and delivery costs.

Precept and Council Support Grant - The first precept instalment of £14,250 has been received. A second instalment of the same amount will be received in September 2015.

Insurance – A renewal quote of $\pounds 2014.56$ has been received and is in accordance with the 5 year quote the Parish Council accepted on 11^{th} June 2012.

PAYE RTI – The end of year PAYE has been submitted to HMRC.

Churchfield Road, Tewin - Surface dressing along is due to take place between 13th and 16th May 2015.

Gully Cleansing Schedule - This is due to take place between 26th May and 29th May 2015.

Manhole Cover on May Pond Green - Two quotes have been received and the Parish Council agreed to accept Freerange Building Solutions quote of £290 for a new heavy duty manhole cover.

Press Release - The Welwyn Hatfield Times printed an article about saving the 388 bus last week.

10. PAVILION AND UPPER GREEN

Playground Inspection – The annual playground inspection by ROSPA has been organised by East Herts Council and will take place in June 2015.

Tennis Court Fencing - The Parish Council has obtained a further quote of £5056 plus vat from Steelway for replacement fencing on both the southern and eastern sides of the court. The Parish Council agreed to outline the proposal for replacement fencing and screening in the newsletter being sent to the parish imminently and agreed to get another quote. East Herts Council has confirmed in writing that no planning permission is required. The Parish Council asked Tewin Tennis Club to ascertain whether they would be making a contribution to the replacement fencing.

Shed - A new shed has been installed behind the Pavilion.

Request to use Upper Green - Welwyn St Mary's Football Club requested use of the football pitch on Upper Green. The Parish Council agreed that they were unable to offer them the pitch.

Parish Paths Partnership scheme (P3)- The P3 grant application form has been successful and a £1000 grant towards resurfacing works on BR8 where it starts from Upper Green past Piggott's and FP26 where it leaves Upper Green Road has been agreed. The remaining £200 will be met by Tom Goldsmith, Countryside Access Officer, Rights of Way Service.

Tewin Cricket Club Benches - A request has been made to allow two benches to be fixed under the trees adjacent to the Pavilion. The Parish Council advised that benches should not be fixed permanently under trees.

Pavilion Extension Proposal - The Parish Council agreed to consider Tewin Cricket Club's proposals to extend the changing room at the Pavilion.
