### **86. FINANCE**

Accounts for Payment - In accordance with the Council's Financial Regulations the schedule of payments approved by the Parish Council since 5th November amounted to £3555.98 from the Current Account. The main cheque was to Kirkham Contracting for £2347.30 for footpath grass cutting in the parish over the year in accordance with the 3yr quote accepted 6th March 2017.

**Estimate to the Year End -** In accordance with the Financial Regulations of the Council the Parish Council reviewed and agreed the Estimate for the Financial Year Ending 31.3.2020.

**Precept** –The Parish Council reviewed the precept options for the Financial Year Ending 31.3.2021 and in accordance with the Financial Regulations of the Council they unanimously agreed that the precept be increased by 1.63% from £30,500 to £31,000 in line with inflation.

**Subscriptions -** The Parish Council agreed to continue with the existing subscriptions: CPRA, CDA for Herts, Open Spaces Society, Herts & Middx Wildlife Trust and Society for Local Council Clerks.

**Reserves -** The Parish Council agreed that reserves were sufficient.

**Grass Cutting Tender:** The Parish Council agreed to request a 4yr contract from Kirkham Contracting and then decide whether to go out for tender.
