Minutes of the Parish Council meeting held on Monday 7th February 2022 at Tewin Memorial Hall at 7.45pm.

PARISHIONERS COMMENTS

David Rixson attended to answer any questions about the Brief Landscape History of the Mimram Valley and The Case for a Local Landscape Designation. These represent the first stage of the Lower Mimram Valley Initiative (LMVI) conceived in response to significant threats to the vulnerable environment between Welwyn Garden City, Digswell and Tewin Village. Copies will be sent to relevant contacts, hard copies will be available to view at Tewin Stores and on the Tewin Village Website.

Stage 2 of LMVI will include: participation in the statutory plan making process; preparation of a landscape recovery plan; the set up of a 'Friends of Marden Fields' website; constitution of a community enterprise to implement plans for the benefit of local people.

The going public date of Monday 14th February was agreed subject to printing being ready.

Cllr K St Pier agreed to review and confirm the mailing list for the documents. David Rixson agreed to provide a covering letter to accompany the documents.

Planning applications

3/21/3076/FUL - Gilpins 1 Cowpers Way, Tewin - Demolition of single storey dwelling and garage and erection of replacement two storey dwelling – *TPC Object – EHC Granted – TPC have written MP Oliver Heald re the concept of "fallback" allows a planning application to take into account possible permitted development extensions when determining the current size of a dwelling.*

3/21/2902/PNHH – 19 Firs Walk, Tewin - Single storey rear extension. Depth: 8m, Maximum height: 3.4m, Eaves height: 2.4m – *Prior approval not required*

3/21/2869/PNHH – 18 Godfries Close, Tewin - Demolition of rear extension and erection of single storey rear extension: Depth: 6.00 metres, Maximum height: 4.00 metres, Eaves height: 2.50 metres; garage conversion; alterations to fenestration and front entrance way and the addition of a new window and door to the side elevation – *Prior approval not required*

Enforcement

<u>Glamping</u>: The Parish Council has become aware that Tewin Bury Farm and Land to West of Orchard Road, Tewin are preparing to set up "glamping" sites.

The Duty Planning Officer advised that if the land is agricultural then it would be a change of use and therefore need planning permission.

<u>Dog Park:</u> A dog park with a car park, fencing and wooden structure has just opened up off Churchfield Road, Tewin in a field. This was reported to East Herts Council Planning Enforcement.

The Duty Planning Officer advised that if the land is agricultural then it would be a change of use and therefore need planning permission.

<u>Mobile Home:</u> The appeal for the temporary siting of a mobile home on agricultural land west Of Orchard Road was dismissed on 21.5.21. The mobile home is still in situ and Enforcement has been advised.

<u>E/20/0065/ENF - Dawley Woods</u>, Tewin – Concerns about a mobile home with no planning permission, concerns a puppy farm being run, dogs bark through the night and are on the loose on the site.

EHC advised that the site has been visited and the 'mobile home' in the woods has been dismantled. A further visit will be made to check that the site has now been cleared of the resultant waste before the case is closed.

No evidence of a puppy farm has been seen at the site.

Lower Mimram Valley Initiative – The Parish Council unanimously agreed to adopt the reports and to write a thank you to the committee.

Article 4 Directive – This has been made permanent on land under the viaduct in Digswell and the Parish Council agreed to write to East Herts L Haysey requesting this for plotlands.

100. FINANCE

Queen Hoo Lane – Clerk to report a pothole outside Cheltenham House to Herts Highways.

Margery Lane Cut ins – The Parish Council agreed to ask Kirkham Contracting to renew the cut ins and Cllr D Howson agreed to oversee.

Platinum Jubilee Celebration – The Parish Council agreed that Lower Green could be used by Friends of Tewin on 2^{nd} , 3^{rc} and 4^{th} June 2022.

103. PAVILION & UPPER GREEN

Weekly Playground Inspections - Nothing to report.

Pavilion Changing Room Works – These have been completed and the Parish Council agreed to pay the invoice. **Platinum Jubilee Celebration** – The Parish Council agreed that Upper Green could be used by Friends of Tewin on 5th June 2022

Cannons Meadow Replacement Post and Rail – These works have now been completed. **Tree Survey** – Due to start by the 24th Feb and will take approx 10 days.

105. DEFIBRILLATOR TESTING – The Parish Council agreed to replace the pads and batteries at both the Memorial Hall and Burnham Green Village Hall as they are near their expiry date. Burnham Green Village Hall Committee and Datchworth Parish council will reimburse the costs for the latter.
