TEWIN PARISH COUNCIL

Minutes of the Parish Council meeting held on Monday 5th September 2011 in Tewin Memorial Hall at 7.45pm.

PRESENT: Cllrs K. Lawson (Chairman), K. St Pier (Vice Chairman), B.Evans, P.Fulford, A.Hill, D.Howson and D. Lloyd.

In attendance: Mrs C.McFarlane (Clerk), East Herts District Councillors L.Haysey, East Herts District Councillor M.McMullen and one member of the public.

44. APOLOGIES FOR ABSENCE were received from Cllr J.Sheridan.

PARISHIONERS' COMMENTS

Mr J.Burton attended to express his disappointment at the ever increasing urbanisation of Tewin. He in particular cited the Segway Adventure signs in Orchard Road, the red brick front wall and gates at 53 Orchard Road, an A Board on the village green in front of the Plume of Feathers and the new white fence at 54/56 Upper Green. He also advised that the banner and sign at the Rose & Crown along with the Tewin Memorial Hall banner were inappropriate for the Conservation Area. He informed the Council that the entrance of the temporary car park, adjacent to FP30 as it reached Queen Hoo Lane, crossed Common Land and that at 7 Bishops Road a hedge planted to comply with a planning condition had been removed.

45. MINUTES OF THE PREVIOUS MEETING held 4th July 2011 and 8th August 2011 were agreed and signed by the Chairman.

There were no declarations of interest.

47. MATTERS ARISING FROM THE MINUTES

48. FINANCE

Accounts for Payment - In accordance with the Council's Financial Regulations the schedule of payments amounting to £3,343.11 from the Current Account were approved by the Parish Council.

Tewin Memorial Hall – In accordance with the minutes dated 9.5.2011 the Parish Council provided a £900 donation in support of a Biffa grant application being made by the Memorial Hall.

External Audit – This has been completed satisfactorily and displayed on the Parish Council notice board for the statutory 14 days. The Parish Council noted that the Section 1 comparatives did not add up by $\pounds 1$.

Internal Audit – The internal audit with Cllr B.Evans took place on Monday 11th July 2011 and everything was satisfactory.

Bank Accounts – These have been changed over to a Community Account with free banking as banking charges were being brought in on the old account.

Updating Signatories – The Parish Council agreed that Councillors K.Lawson, K St Pier, B.Evans, P.Fulford, A.Hill, D.Howson, D.Lloyd and J.Sheridan would be signatories on all accounts and signed the forms accordingly. All cheques and withdrawals continue to require two signatures from authorised persons.

Parish Council noted correspondence received from a parishioner objecting to the planning application. 3/11/1037/FP - 2 Hertford Road, Tewin – Erection of Two Residential Dwellings and Garage for Existing House – The Parish Council noted correspondence from the developer and agreed to send a letter of support to East Herts Council as at the Parish Council meeting on 8th August 2011 parishioners were supportive of the proposed 2 detached houses as the buildings were not right at the back of the existing garden at 2 Hertford Road and that Tree Preservation Orders had been placed on the apple and walnut trees.

Appeal Decisions

3/10/1785/FP – Tewin Garage, 41 & 41a Upper Green Road, Tewin – Demolition of existing garage, petrol filling station, workshops and existing house. Erection of 3 detached houses and a two storey office building with new vehicular access and associated off street parking.

The Inspector allowed the appeal and waived compliance with Condition 20 regarding the provision of affordable housing.

Enforcement Issues - None.

East Herts Council SLAA Partnership Meeting – The Parish Council agreed that the Clerk will attend the first meeting on 19^{th} September 2011.

50. HIGHWAYS

Salt Bins – HCC have asked for another map marking the proposed location of the new salt bin. The Clerk is also awaiting a response from HCC about the replacement salt bin outside the village shop.

51. PAVILION, PLAYGROUND & UPPER GREEN

Tennis Club and Valuation Office – Mr D.Room, Chairman of Tewin Tennis Club, advised that he has written confirmation of 100% small business rate relief for a year. He has also lodged a proposal with the Valuation Office seeking deletion of the tennis courts entry on the grounds that Tewin Tennis Club does not have exclusive occupation of the courts. He is currently awaiting a response.

Pavilion CIC and Valuation Office – The CIC has submitted a counter rating proposal to the Valuation Office and is awaiting a response.

Tewin Pavilion CIC Report – The Parish Council were pleased to read that the Pavilion is in a sound financial position to continue business and to promote new activity.

Tewin Pavilion Water Inspection – Cllr D.Howson completed the water inspection on 8^{th} August 2011 and asked the Clerk to advise the Tewin Pavilion CIC that the once a month the hot water needs to be switched on and run through the entire system. The next water testing date is 6^{th} September 2011.

Fire Risk Assessment – A meeting has been set for Monday 12^{th} September 2011 at 2.30pm when the Parish Council and the Tewin Pavilion CIC will complete the fire risk assessment.

Playground- Nothing to report on inspections. Cllr A.Hill advised that the works on the playground fence will take place shortly.

Dog Fouling on Upper Green – The dog fouling sign has been received and will be put up shortly on Upper Green. The Parish Council agreed to put dog fouling signs on the notice boards.

Pond Clearance – Mr Loughrey has kindly agreed to remove various dead trees around the pond in accordance with the professional survey so as to allow more natural light onto the pond. The Parish Council agreed to the works.

Car Park – The Parish Council has received two complaints about the surface of the car park not being suitable for disabled access or pushchairs. They agreed to continue to monitor the situation over the winter. The Parish Council agreed to advise the Tewin Pavilion CIC that loading and unloading would be permitted in front of the Pavilion for disabled visitors only.

Litter Bin Collection – The litter bins will now be emptied weekly on Mondays. New Litter Bin – This has been received and will be installed in due course. Rose & Crown – The Parish Council agreed to write to the landlord.

53. RISK ASSESSMENT

Annual Risk Assessment – Remedial works have not been completed yet.

Hertfordshire Waste Core Strategy and Development Management - A pre-hearing meeting is on 29th September 2011 at 10am at County Hall.

Tewin Bury Farm Green Apple Award – An invitation has been received to attend the award ceremony on November 14th 2011. Cllr K St Pier agreed to attend.

Footpath 30 from Tewin Wood to Queen Hoo Lane - The landowner has provided an alternative route so that the driveway to Bramble Lodge does not need to be crossed. The Countryside Access Officer from Herts County Council is fully aware of this and has advised the landowner that the historic definitive line of the path must remain open and available. The Parish Council agreed to continue to monitor the situation.
