# **Planning applications**

3/23/0352/HH – 23 Bishops Road, Tewin - Demolition of detached garage, rear conservatory, external staircase and front dormer window Erection of a new part two storey/part single storey front extension – *TPC request removal of PD rights on this application. The Council are concerned at the knocking down of the garage as part of justifying the size of the main extension and securing permission and then putting in another application to replace it by an extension.* 3/23/0343/CLPO – 23 Bishops Rd, Tewin - Demolishing detached garage and erecting a single storey side extension. 3/23/0375/VAR - The Old School House Lower Green, Tewin - Erection of single storey rear extension and alterations to fenestration. Variation of Condition 2 (approved plans) of 3/22/1225/HH: Alteration to the size and position of the glazed doors on the side elevation and installation of a roof light on the flat roof – *TPC No Comment*

**Tewin Boundary Signs** - The Parish Council are currently waiting for a reply from Herts Highways having decided upon the location.

**Defibrillator** – Both the Tewin Memorial Hall and Burnham Green Village hall defibrillators were removed from the cabinets during the month by the Ambulance service and returned the next day. The Circuit has been updated. **Bowls Club** - The Bowls Club re the works being completed prior to obtaining planning permission

**Coronation Village Street Party** – The Parish Council agreed to the request from Friends of Tewin to use Lower Green for a Coronation Village street party on 7<sup>th</sup> May 2023.
