46. PLANNING

Planning Applications

HCC Outstanding invoices – Kirkham Contracting has several invoices unpaid by HCC and the Clerk has resubmitted them and chased them.

48. HIGHWAY MATTERS

Tewin Boundary Signs – G Taylor, Herts Highways Engineer has provided details on locations and various design alternatives. The Parish Council agreed to forward the information to Friends of Tewin.

Orchard Road Resurfacing – The top of Orchard Road at its junction with Burnham Green Road will be resurfaced on 8th September.

Abandoned Car – This was reported to East Herts Council and DVLA and has been moved off the road.

Abandoned Van – This was reported to East Herts Council and the DVLA and has moved.

49. LOWER GREEN

Land Adjacent to Rose & Green, Lower Green – The adjacent householders were all happy for the ground under the trees to be cleared. The Parish Council agreed to get some quotes and Cllr D Howson agreed to meet the contractors.

Christmas Tree Electrics – The Parish Council agreed to accept the quote of £312 for repairing the power supply to the Christmas Tree.
