## **Planning Applications**

3/25/1072/VAR - Caverswall, Queen Hoo Lane, Tewin - Variation of Condition 2 (approved plans) to ref:

3/25/0053/HH for removal of the single storey rear projection with roof terrace above. Construction of single storey rear extension with roof terrace and balustrades above and incorporating rooflight windows. New first floor and ground floor front windows. Balustrades added to the existing flat roof.

3/25/1263/ARPN - Land West Of Back Lane, Upper Green, Tewin - Convert an existing barn and provide a rear extension on existing hardstanding to create 1 dwelling, provide two parking spaces, accessed via an existing entrance.

**VAT Reclaim** – The VAT reclaim of 211.34 was received on 18.7.25.

**Internal Audit** - The internal audit date was completed on 22<sup>nd</sup> July 2025 by Councillor Bryan Evans and everything was found to be satisfactory.

External Audit – PKF Littlejohn are in the process of completing the audit.

**Clerk Pay Increase** – The Local Government Service Pay Claim 2025/26 has been agreed and the Parish Council agreed to the pay increase for the Clerk and backdated it to 1.4.2025.

**Donations** – These have been received from Tewin Tennis Club towards the maintenance of the courts, Tewin Pavilion CIC towards the service of the fire alarm & extinguishers and the PAT testing, and from Tewin Allotments towards fencing works.

Parish Online - The Parish Council noted renewal of annual membership of Parish Online.

**Allotment Rent** – The six monthly invoice for the rent of the parish allotments has been sent to Tewin Allotment Association. **Lower Green Cubicle Electricity Supply** – A backdated invoice £688.74 for the period 28.2.2022 ~ 31.5.2025 has been received. A payment plan of £57 per month for 12 months has been agreed and will be added to the monthly direct debit of £18.65. EON has provided a credit note for £40 in lieu of compensation. The Parish Council agreed to raise this again with EON re energy back billing rules.

**Allotment Tenancy** – The Parish Council noted that this expires on 4.4.2026 and the Parish Council agreed to contact the landowners concerning the way forward.

## 44. HIGHWAYS

Broken Gates - The Parish Council agreed to accept a quote from Kirkham Contracting to tidy up and repair fencing

around various gates. Mr I Williams also advised that he would be repairing the 2 sets of swing gates and posts on his

School Lane – Affinity Water have completed remedial works on the sinking road outside 2 School Lane however the new works are also sinking and the Clerk was asked to report this.

**Tewin Hill Fencing** – Highways have installed the new post and rail fence.

Gulleys – Highways have cleared some of the gulleys in Upper Green Road. The gulley opposite Godfries Close is now working. The gulley outside Sevenacres is likely to need further remedial works.

**FP18 Missing Bollard** – The Clerk will report it to the Rights of Way unit.

#### 45. PAVILION & UPPER GREEN

Weekly Playground Inspections - Nothing to report.

**Pavilion Fire Alarm Service** – The remedial works were completed on 22<sup>nd</sup> July 2025.

Pavilion Fire Extinguisher Service – These were completed on 22<sup>nd</sup> July 2025

Pavilion PAT testing – This was completed on 22<sup>nd</sup> July 2025 and one kettle failed and has been removed.

Tennis Court Hedging – The Parish Council agreed to accept two parts of Kirkham Contracting's quote for hedge cutting around the tennis courts.

**Sovereign Network Group** – A works order has been raised for the hanging trellis and leaning fence to be made safe interim. They have also requested a quote for trimming the trees overhanging the tennis courts at Upper Green.

Use of Upper Green – The Parish Council agreed that DH Dance Academy to use Upper Green on Sunday 14th Sept 2025 subject to the usual village green stipulations

### 46. LOWER GREEN

**Telephone Box** - Replacement windows for the telephone box have been ordered.

Rose & Crown – A concern was raised by the bus passengers that tables and chairs outside the pub no longer leave enough room for the bus to pull over and allow its passengers to disembark. Cllr D Howson agreed to speak to the landlord.

St Peters- Reinstate 2 posts – The Parish Council agreed to look into this further.

Tewin Hill – Roadside fence still down – Highways have completed the works.

Todds Green – Removing 5 x tree stumps and flail mowing area – The Clerk to chase.

Tree Risk Assessment – Following the survey of the Area 3 Bramfield Road and Queen Hoo Lane on 9<sup>th</sup> July, a quote of £4,704 excl vat has been obtained from Rob Cooper. The Parish Council agreed to arrange to get another quote.
