## **TEWIN PARISH COUNCIL**

Minutes of the Parish Council meeting held on Monday 12th November 2018 in Tewin Memorial Hall at 7.45pm.

- **61. APOLOGIES FOR ABSENCE** received from Cllr N. Moore, Cllr J. Sheridan, East Herts Councillor Michael McMullen, East Herts Councillor Linda Haysey and Herts Councillor Ken Crofton.
- **62. THE MINUTES OF THE PREVIOUS PARISH COUNCIL MEETING** held 1st October 2018, copies of which have been previously circulated to Councillors were confirmed as a true record and signed by the Chairman.

### 63. NO DECLARATIONS OF INTEREST

## PARISHIONERS COMMENTS.

One parishioner came to ask what could be done about the excessive height of the non indigenous Leylandii hedging around the chicken field and the untidy state of the field which is in the Green Belt.

Twelve parishioners attended to object to the planning application for the Fairholme Stables planning applications. The objections included, the dangerous access onto the single rural lane, no plans to widen the road, lack of visitor parking, openness of green belt compromised, green belt urbanised, views across countryside spoiled, lack of consideration for HGV traffic such as: refuse, fire engine, deliveries, and application trivialised traffic impact.

Two parishioners complained about three cars full of household rubbish being kept on the front garden of 6 Grass Warren and it being a health hazard. The Parish Council agreed to report this to Riversmead Housing Association.

3/18/1834/HH - Bracken Hill Queen Hoo Lane, Tewin - Erection of front porch, single storey side extension, part single, part two storey rear extension, erection of pitched roof above existing single storey side extension, raising roof height to provide accommodation in roof space to include a roof terrace to the rear, alterations to window sizes and openings and associated design alterations including application of render - TPC No Comment - Applicant Withdrawn.

3/18/2014/FUL - 11 Cowpers Way, Tewin - Replacement Dwelling - Received on 1.10.18 so the Parish Council will contact neighbours as per usual and will hold an extraordinary meeting if necessary prior to the closing date of 2nd November. The Parish Council requested an actual comparison between the profiles of the new dwelling and its neighbours rather than just a street scene illustration, confirmation that the small first floor window on the right flank is a bathroom window and therefore fixed obscure glass, copies of the two public comments against the previous application 3/17/1991/FUL, since these have now been removed from the website - *EHC Granted*.
3/18/1796/OUT - Land At Upper Green Road, Tewin - Construction of 4no Dwellings. 3no Affordable Houses consisting of 2 no. Two Bedroom and 1 no. Three Bedroom Marketable House and new vehicular access - *TPC Object - EHC Refused*.
3/18/1777/FUL - Tewin Water Farm, Churchfield Road, Tewin - Construction of a new farmyard including 3 new agricultural buildings, associated yard area, cattle handling pens and silage storage area, landscaping and drainage - *TPC No Comment - EHC Refused*.

# Appeal Submitted

3/18/1602/HH - Timbertops 34 Firs Walk, Tewin - New front facade of dwelling house: - replacement of garage door with a two casement windows: new front entrance hall, two dormers at first floor level: new bi-fold doors and Juliet balcony to the rear - TPC No Comment - EHC Refused.

# **East Herts District Plan**

On 23rd October 2018 East Herts Council adopted the East Herts District Plan as a development plan document. The Inspector confirmed, subject to a number of main modifications, the Plan was sound and recommended its adoption. The Parish Council agreed to put this in the Tewin Magazine along with some information on how it impacts Tewin.

#### Panshanger Airfield Master Plan

A master plan has been submitted for the housing development on Panshanger and it includes 650 house as well as how an additional 165 houses could be included.

#### 65. FINANCE

**Accounts for Payment** - In accordance with the Council's Financial Regulations the schedule of payments approved by the Parish Council from the Current Account since 3<sup>rd</sup> July 2018 amounted to £6705.53.

**VAT Reclaim** – This has been received.

**Internal Audit** – This was completed on 24<sup>th</sup> October at 10.30am by Cllr B Evans and D Lloyd and everything was found to be satisfactory.

**Next Years' Budget** – Councillor's noted the estimate to year end and budget options for the next financial year will be discussed at the next meeting.

**FP13 Levelling** – On 12 November 2018 Kirkham Contracting advised that it will be completed shortly.

Godfries Close Access Resurfacing - The Clerk to contact East Herts Councillor Linda Haysey.

Maypond Green Tree Pruning - Kirkham Contracting has advised that it will be completed shortly.

Lousehole Bottom Bollards - The Clerk will liaise with Tom Goldsmith about this and the drainage works necessary on BR4.

Plume of Feathers Sleepers - The Clerk will contact Greene King.

# **67. HIGHWAYS MATTERS:**

**Priority Gulley Cleansing -** Herts Highways have advised that they have visited all the priority gullies.

Water Leak outside 106 Orchard Road - Affinity Water advised that it is not a mains water leak. Herts Highways advise that they will need to close the road and undertake CCTV drainage investigation. The Parish Council asked that Highways clear the gulley so that the water, wherever it may be from, drains off the road.

**Items of Interest from County** - The Parish Councillors noted Herts County Councillors Ken Crofton's brief update email. **Road Closure** - The Council noted that Hertford Road will be closed for underground cabling works on a non specific date.

**Road Safety Fund** - An application has been submitted on behalf of Tewin Drivesafe Team to the Police & Crime Commissioner for £1700 towards a second socket for the speed indicator device.

**Car Repair Works** - A complaint has been forwarded to the HCC enforcement Team about car repairs and oil spillages on a constant basis on the lay-by in Grass Warren.

# 68. PAVILION AND UPPER GREEN

Weekly Playground Inspections - Nothing to report.

**Annual Playground Inspection** – Cllr B. Evans and the Clerk met SM to request quotes for new surfacing and additional pieces of equipments following an indication of a donation from Friends of Tewin.

**Pavilion Extension Publicity** – The Parish Council agreed to arrange a Village Network event in March 2019 at Tewin Pavilion via Tim Hayward Smith of CDA for Herts and Claire Pullen at East Herts Council.

**Pavilion** - Quotes are being obtained for replacement hand dryers in the toilets and 2 more tubular frostat heaters in the toilets. **Pavilion Path Lights** - The light bulbs have been replaced.

**Tree Works** - Herts County Council, Rural Estates Department have apologised for the error concerning Gristwood & Toms removing trees on Upper Green on 9th August and on 11th October. HCC has confirmed that they have made a note on the files so this won't happen again. A copy of the tree survey has been requested for Tewin Parish.

Sign – The Parish Council agreed to accept the quote of £128 plus vat for a replacement "No Unauthorised Vehicles" sign to go on Upper Green.

#### 69. CORRESPONDENCE

One parishioner came to ask if there was anything that could be done about the Leylandii around the chicken field and tidying up the plot **Upper Green Tree Works** - A complaint was received about the felling of a tree by Gristwood & Toms on 11th October on behalf of Herts County Council - Refer Paragraph 68 - Tree Works above.

**Chicken Field** - A complaint has been received about the untidy state of the chicken field and the height of the Leylandii. The Parish Council agreed to take this up with East Herts Council.
