#### **TEWIN PARISH COUNCIL**

Minutes of the Parish Council meeting held on Monday 7<sup>th</sup> November 2022 at Tewin Memorial Hall at 7.45pm.

**64. APOLOGIES FOR ABSENCE** received from Cllr N.Moore, East Herts Cllr L.Haysey, East Herts Cllr M McMullen and Herts County Councillor K Crofton.

**65. THE MINUTES OF THE PREVIOUS PARISH COUNCIL MEETINGS** held 3<sup>rd</sup> October 2022, copies of which have been previously circulated to Councillors, were confirmed as a true record and signed by the Chairman.

## **66. PARISHIONERS COMMENTS**

Lesley Davies, Chief Executive of the Herts & Middx Wildlife Trust (HMWT) advised that they have purchased the Archers Green site to protect it and manage as one of their nature reserves. It has an important mix of habitats and wildlife and the nationally important River Mimram. HMWT have the benefit of a philanthropic loan and have now launched a £500,000 public appeal to repay the loan and raise the funds for the purchase costs, ongoing management and improvements. The Parish Council agreed to assist them in promoting the site using flyers, newsletter and the village website. They plan to manage the site on an agricultural basis for the benefit of the wildlife and use livestock.

David Rixson, Lower Mimram Valley Initiative (LMVI) outlined the plan for the Repton trail from Digswell to Panshanger Park using existing footpaths. LMVI and HMWT hope to work together.

**East Herts Council Planning Forum** – The Parish Council submitted a question which was answered at the meeting. The minutes have been requested.

#### 69. FINANCE

Accounts for Payment - In accordance with the Council's Financial Regulations the schedule of payments approved by the Parish Council amounted to £2,250.92 comprising: Npower £14.87, Lock & Key Centre £197.58, Tewin Memorial Hall £76.50, ROSPA £56.80, Kirkham Contracting £528, PKF Littlejohn £408, NEST £83.44, C McFarlane £810.73, Royal British Legion £75.

Internal Audit – This was delayed by Covid and re arranged for 16<sup>th</sup> November 2022.

**Pavilion CIC Donation** – A donation of £836 was received towards various works at the Pavilion.

**Royal British Legion** – The Parish Council agreed to make a donation of £75 to the Royal British Legion for a wreath. **HMWT** – The Parish Council agreed to assist HMWT in promoting the recently purchased Archers Green site through flyer distribution, newsletter and the website.

**External Audit** - The AGAR audit has been completed by PKF Littlejohn and they found everything to be satisfactory except for the statutory amount of time the accounts had been available for inspection by the public, which was one day shorter than the requirement as the bank holiday on 3<sup>rd</sup> June was not taken into account.

**Allotment Rent** – This has been received.

**Tel Box Electricity** – The Parish Council agreed to put this on direct debit.

#### 70. HIGHWAY MATTERS

Ref: 401002710305 - Upper Green Road Broken Birdsmouth Fencing – The broken part has been cut off.

**Broken Manhole Cover on Orchard Rd** – This has been repaired.

**Pothole in Orchard Rd next to leaking gulley** – This is opening up and needs to be reported.

Orchard Road Leaking Gulley – The ongoing leak has been fixed however the gulley remains blocked.

**Pavement Renewal Grass Warren** – Highways have completed renewal of the pavements along the south side of Grass Warren.

**Ref:** 401002727501 - Churchfield Road Potholes – The large potholes on Churchfield Road between 1 Churchfield Cottages and the back entrance to Tewin Bury Farm were reported on 7.6.22 & 4.7.22 but have not been filled. This was raised with Cllr K Crofton on 4.7.22 and 27.9.22. Highways Engineer will chase up.

**Ref:** 401002662393 – Lousehole Bottom Cut In Clearance – Reported on 26.4.22. Under review by local engineers. Hertford Rd Flooding – The blocked gulleys are causing flooding across the road and this has been reported to Highways

## 71. LOWER GREEN

**Temporary Shop Sign** – The Parish Council did not agree to the request for another sign on Lower Green as they have a policy of keeping signage on Lower Green to a minimum and there are already two signs as a result of previous requests made by the shop: on the finger post opposite the Memorial Hall and the wooden post by Back Lane.

**Santa's Drive Through and Carols** - Santa Drive Through is at 4pm on 17.12.22 followed by Carols at Rose & Crown pub at 7pm.

#### 72. PAVILION & UPPER GREEN

Weekly Playground Inspections - Nothing to report.

Pavilion Fixed Wire Testing – The overall result was satisfactory and points raised were investigated :

Distribution boards made from combustible material (plastic)- New consumer units are now metal but no change necessary.

No surge protection to installation - A new requirement introduced in 2018 but not necessary.

Query over Internal water pipe bonding to an earth rod – This was noted and deemed covered by the RCD.

**Football posts on Upper Green** – The Parish Council agreed to purchase a pair of aluminium freestanding basic 12' x 6' goals to go on Upper Green.

Overgrown Hedges - Owners of hedges overgrowing FP15 have been asked to reduce them

May Pond Green – This has been cleared.

**Friends of Tewin Beacon Request** - The Parish Council could not envisage a suitable position either on Lower Green or Upper Green and were of the view that the occasions for potential use are extremely limited. As a result the Parish

Council did not feel it could support the proposal.

**HMRC** - Revaluation request for the Pavilion has been received by the CIC. Cllr J Sheridan has completed the forms and is waiting for a site visit to be arranged.

### 74. CORRESPONDENCE

**Electric Vehicle Charging Survey** 

Hertfordshire County Council's School Admission Arrangements 2024/25 Consultation closing 11<sup>th</sup> December 2022 Hedgerow and Tree query – The parishioner was advised that the Parish Council was not aware of there being any protected hedges at 64 Orchard Road, or of any rule about not building within one meter of a protected hedge. The plot is covered by a tree preservation order, which will include trees in hedgerows, but not the hedgerows themselves. In the tree survey T7, T11 are oaks in the front garden of poor quality and to be removed along with T20. T25 is at risk and being monitored.

## 75. REPORTS FROM REPRESENTIVES TO OUTSIDE BODIES AND SPECIAL RESPONSIBILITIES

**Transport** – New figures for the Saturday bus usage are expected in December, Cllr K Lawson is also following up Digital Inclusion which involves training potentially through the Over 50's Club. The road closures brought about by Highways happened so quickly that the bus companies were not informed.

**Policing** – The Parish Council agreed to raise the dangerous parking on the bend where Grass Warren joins School Lane.
