PARISHIONERS' COMMENTS

The Parish Council referred to the existing Defra guidance and suggested that further information should be sought on how the problem could be tackled.

Allocation of Funds for Seat in Bus Shelter – A seat, formerly used in the bus shelter, has come to light in the village and Cllr S.Stott proposed that it should be put back into the bus shelter and the situation monitored, Cllr C.Pool seconded this proposal and the motion was agreed with 6 votes for and 1 abstention. The Council agreed that a limit of £75 should be paid for this to be done and that the seat must be risk assessed. The Council also asked that the Police should be notified.
