### PARISHIONERS COMMENTS

Ten parishioners attended the meeting to object to the planning application proposing two new residential dwelling on land at the rear of 2 Hertford Road. Most of them had sent their objections to East Herts Council and sent a copy to the Parish Council. Their concerns were over size, scale, mass and layout of the proposed buildings, the impact on the Conservation area, overdevelopment and inappropriate development of the site, overshadowing and overlooking of nearby bungalows and the right of light, the loss of trees, insufficient parking and the presence of badgers in the vicinity,

## 6. FINANCE

**Accounts for Payment** - In accordance with the Council's Financial Regulations the schedule of payments amounting to £805.85 from the Current Account were approved by the Council.

**Insurance** – The Parish Council agreed to accept the renewal quote of £1702 from Allianz which is an increase of 8% on last year's.

**Public Works Loan Board ("PWLB")** – The Secretary of State has given Tewin Parish Council a borrowing approval not exceeding £80,000 for the complete refurbishment of the Pavilion. The borrowing approval is valid for six months from the 20<sup>th</sup> April 2010.

## 7. PLANNING

**Planning Applications received** 

3/10/0359/FP — Land R/O 2 Hertford Road, Tewin — Erection of two residential dwellings and new access drive — TPC supported the parishioners objections by reason of their size, scale, mass and layout would appear unduly prominent and visually intrusive from the street and out of character in the surrounding area contrary to policies ENV1, ENV2 and HSG7 of the East Herts Local Plan Second Review April 2007. The scale and the design of the buildings would fail to preserve or enhance the Conservation Area as would the loss of trees on the site. This proposal has not provided sufficient parking and there is already a parking problem in the village so there is no room for "on street" overflow parking. The parishioners in the vicinity of the development are aware of the presence of badgers and believe there could be badgers sett nearby which should be investigated. They were also concerned that the proposed houses overlooked the ground floor bedrooms at the rear of the bungalows along Cannons Meadow.

## **Planning Responses from EHC**

Cllr A.Hill declared an interest in the next item as he is a neighbour

3/10/0331/FP/HS - Rear of 78 Upper Green Road, Tewin - Erection of Detached House and Garage -

TPC object to this proposal as the four first floor windows in the proposed development will overlook the immediate neighbours at 78 Upper Green Road, whose house is a 300 year old listed building. This will invade their privacy and intrude on their personal living space as they will be overlooked, particularly as the main entrance to the building is at the rear. There seem to be acceptable alternatives as three windows could be re located on alternative elevations and the landing window could be opaque.

The Parish Council fully support the objections of the immediate neighbours, at 78 Upper Green Road and the letter of support signed by 60 parishioners who objected to the proposal.

EHC – Refused due to scale, bulk, design being unduly dominant and out of keeping with the character of the surrounding area.

3/10/0415/FP - 16 West Riding, Tewin - Single storey side extension and detached open fronted double garage - TPC No Comment - EHC Granted
