

## TEWIN PARISH COUNCIL

**Minutes of the Extraordinary Parish Council meeting held on Monday 8<sup>th</sup> August 2011 at Tewin Pavilion at 7.45pm.**

**44. APOLOGIES FOR ABSENCE** were received from Cllr B.Evans, Cllr P.Fulford, East Herts District Councillor L.Haysey and East Herts District Councillor M.McMullen.

### **PARISHIONERS COMMENTS**

Mr I Williams and Mr V.Williams from Tewinbury Farm attended to answer any queries on the planning application. They explained that the marquee has to be taken down in January 2012 and the application is to use an existing barn as temporary accommodation for conferences and events. The barn is dug into a hill so will be well insulated from a noise perspective.

Mr V.Williams also advised that Tewin Bury Farm has won a National Award for Green Hotels and he invited a member of the Parish Council to attend the Award Ceremony at the House of Commons on November 14<sup>th</sup> 2011.

Some residents from Cannons Meadow attended to express their opinion on the planning application for 2 Hertford Road. They were supportive of the proposed 2 detached houses as the buildings were not right at the back of the existing garden at 2 Hertford Road and that Tree Preservation Orders had been placed on the apple and walnut trees.

Mr Compton explained that East Herts Council would prefer to have three houses on the plot.
