6 Changes to Constitution and Rules

Ray Keppler stated that, as members had been notified, the committee was proposing a change to the constitution to give more flexibility on setting the date of the AGM. The intention would be to hold future AGMs in March (rather than January), which should prove more convenient for members and guest speakers, in that there was less likelihood of travel to the meeting being disrupted by severe weather.

The change was proposed by Jim Hall, seconded by Keith St. Pierre and agreed by the membership without dissent.

The revised paragraph of the constitution reads as follows:

An Annual General Meeting of the Society shall be held <u>no later than 30th April</u> of each year for the purpose of: receiving the Committee's report on the work of the Society during the preceding year; receiving a Receipts and Payments Account and Balance Sheet signed by the Auditor; electing Officers and members of the Committee; any other business, of which three weeks' notice has been given to the Honorary Secretary or which the Chair shall rule is in order. Decisions taken at an Annual General Meeting shall be by a majority decision.

7 Preview of 2019

Ray Keppler spoke about forthcoming events and projects that the committee would be tackling over the coming year.

He drew attention to the information on proposed and fixed events for the current year, which was displayed at the back of the Hall, which were as follows:

- Creative writing workshop on 19th March
- Spring Show on 6th April
- Plant stall at the village fete on 29th June
- Garden visit in July
- Autumn Show on 7th September
- Creative writing workshop in October
- Art workshop on printmaking in November
- Art and craft fair on 7th December

• Museum or Art gallery visit in December

Attendees were invited to select their preferred garden visit from a shortlist of four, as well as to leave comments and ideas about other activities, both new and existing.

He went on to report that the committee was developing a revised communication strategy following the demise of the Newsletter. He stressed that effective communication was key to the success of *THACS* and said that the committee was concerned that some members, who had previously received a paper copy of the Newsletter, might lose contact with the Society. However, he set out three ways in which those members could continue to access information in the future:

- Switching to receiving email communications
- Taking out a subscription to Tewin Magazine
- Checking the *THACS* page on the Tewin website

Ray went on to talk about the ongoing work to enhance the *THACS* web page and to make it more user friendly. He noted that the *THACS* home page had received just under 1,000 hits during 2018 and said the aim was to collect more detailed statistics and utilise them to inform the improvements as well as to judge the success of the website as a source of information. He asked for assistance in this process from anyone with the necessary skills and for others to come forward, if they were willing to test and review the new webpages.

Malcolm Allen said that a great deal had been achieved in 2018 with a small committee and a large group of helpers. He wondered if even more could be undertaken with more people to share the load. He invited suggestions from the membership about any new activities, in which members would like to participate. He further encouraged new people to help organise events and to join the committee.
